The Biological and Physical Resources (BPR) staff of the U.S. Department of Agriculture (USDA) Forest Service, National Forest System (NFS) will soon advertise a key position to provide national leadership to wildlife habitat conservation and management throughout the agency. This position is your opportunity to join the small, deeply committed team providing guidance to the overall wildlife management program, including devising policies and strategies, lending professional expertise, facilitating consensus, and advising senior management officials. Your ideas and recommendations will influence and improve the conservation of terrestrial wildlife and biological diversity, as well as help to evaluate the consequences of resource management policies and decisions on NFS lands.

Strong candidates will have well demonstrated written, verbal, and analytical skills, and ability and experience with the key functions associated with the mission of NFS, including: 1) building effective coalitions and/or partnerships with other agencies and non-governmental organizations to enhance the delivery of Forest Service's multiple-use mission; 2) collaborative problem-solving with external and internal stakeholders to resolve contentious natural resource-related issues; 3) assisting policy and decision makers in understanding complex, cause and effect relationships between fish and wildlife species, their habitats, and management activities; and, 4) coordinating and monitoring strategically important initiatives, partnerships, and/or projects. Work experience that demonstrates a progression of responsibilities from local to regional or national levels, with evidence of effective participation in and leadership of multi-disciplinary teams provides the necessary foundation for success in this position.

The Position

The incumbent biologist, in concert with key national fish and wildlife biologists and ecologists, plays a pivotal role with the Forest Service's management of a suite of critically important natural resource management issues on a national scale. Major responsibilities of this position include, but are not limited to, planning, developing, evaluating, and administering aspects of the wildlife conservation and management programs necessary to meet the Forest Service's mission to sustain the health and diversity of the national forests and grasslands. An important part of the position's duties is serving as a natural resource "consultant" to national and regional staff by providing professional expertise and technical guidance in the solution of unique, challenging wildlife and/or biological diversity-related issues. In addition to a professional background in wildlife science, management, and/or conservation, thorough, practical understanding of the pertinent Federal public lands and resources laws (such as the Migratory Bird Treaty Act or Endangered Species Act) is vital to the position. And most importantly, we are looking for an individual with well demonstrated collaborative leadership skills.
