 - FYI–Forthcoming discussion – who is doing what in response to the following House Appropriations Report Language?: “MONARCH BUTTERFLY POPULATIONS – The Committee is aware the U. S. Fish and Wildlife Service is gathering information to determine whether the monarch butterfly should be listed as a threatened or endangered species under the Endangered Species Act. Monarch butterflies are a fixture in crop fields across the Nation and listing them could have significant impacts on agriculture. The Committee directs the Secretary of the Interior to work with the Secretary of Agriculture in coordination with the states, and private and nonprofit organizations to develop and implement strategies, such as setting up milkweed reserves, to help protect monarch butterfly populations and preserve the natural habitats critical to their survival. The Secretaries are directed to report back within 120 days of enactment of this Act on the status of this plan and any other actions the Departments are taking to encourage support of monarch conservation.”

2018-2020 Strategic Plan Summary

The Association of Fish & Wildlife Agencies is the collective voice of State, Provincial and Territorial fish and Wildlife Agencies.

Mission: To support and advocate for State, Provincial, and Territorial responsibility for science-based fish and wildlife conservation.

Vision: Sustainable fish and wildlife populations and habitat managed in trust for and supported by the public.
