9:25 - State Spotlight: Project WILD in Eastern Washington – Northwest Natural Resources Institute. Marc read a statement from Diahne Gill, Executive Director of NNRI:

The mission of the Northwest Natural Resources Institute (NNRI) is to cultivate a better understanding of the daily importance of our agricultural, mineral, forest and water resources by educating teachers and students about the science, economic and societal aspects of our region's natural resources. This is accomplished through a variety of educational programs including student programs and educator workshops. Formed in August of 1992, we are a 501c3 non-profit organization and a program partner of Greater Spokane Incorporated.

The NNRI presents information on the utilization and economic importance of our natural resource industries by providing activities and information for teachers and students to make informed decisions on the management and use of our resources. The importance of natural resource-based industries to the Inland Northwest as well as the positive environmental protection measures being implemented are featured in all of NNRI's programs for teachers and students.

At our teacher workshops, we feature Project WILD, Project WET and Project Learning Tree curriculums to accomplish our mission. While Covid-19 slowed us down, we were able to present two in-person three-day teacher workshops in July 2021 which featured Project WILD. Between our workshops in Spokane and Pasco, we educated almost 50 teachers and gave them each a curriculum guide. Additionally, in January 2022, we offered a Project WILD Aquatic workshop in Pasco which had 40 teachers registered to attend and again, they received the Aquatic guides. All attending teachers receive clock hours at no additional charge.
