Meeting Purpose: Discuss issues important to fish and wildlife diversity conservation, develop solutions/actions to address problems/needs, and promote learning and networking.

Audience: State/Territorial/DC Wildlife Diversity Program Managers, their staff, and invited partners.

Meeting Site: The meeting will be held at <u>Lake Guntersville State Park</u> along the banks of the Tennessee River in Northeast Alabama. The resort-style park includes 6,000 acres of natural woodlands, 6 miles of hiking and biking trails, a zipline, beach complex, and outdoor nature center.

Lodging: Traci has secured a block of rooms at Lake Guntersville State Park. The name of the room block is Wildlife Diversity Program Managers (Code 52560). Please make lodging reservations at Reservations | Alapark (reseze.net) no later than January 11th, 2025 if you plan to attend the meeting. Lodging booked after this date is subject to best available rates only. If you need lodging outside of the Monday-Thursday room block, make your reservation by calling the SP at 256-571-5440 and they will do their best to accommodate you.

Check-in time is 4:00PM and checkout time is 11:00AM.

Meeting Registration: The registration cost for the meeting is \$200/per person payable by check to the Association of Fish and Wildlife Agencies. The registration fee includes meeting room rental, morning and afternoon break food and beverages, boxed lunch and entrance fee for the field trip, some transportation, and other costs. Checks can be brought to the meeting and receipts will be provided onsite when payment is made. If you cannot pay by check, contact mhumpert@fishwildlife.org. Travel: Lake Guntersville State Park is located at 1155 Lodge Drive, Guntersville, AL 35976. If traveling by air, best options are Birmingham-Shuttlesworth International Airport (BHM) in Birmingham, AL or Huntsville International Airport (Home - Huntsville International Airport (flyhuntsville.com). BHM airport is ~90 minutes (75 miles) from the meeting site, and HVS is

~70 minutes (51 miles). Although no transportation can be provided to and from the airport and meeting site, we will try and facilitate carpooling prior to the meeting for those who need it.

About Guntersville & Surrounding Area: Guntersville (population ~8,000) sits on the banks of the 69,100-acre Guntersville Lake, an impoundment of the Tennessee River and the largest lake in Alabama. The lake is maintained and managed by the Tennessee Valley Authority. Guntersville is named for the great-grandfather of American humorist Will Rogers. The average high temperature for February is 55°F, average low temperature is 36°F, and average monthly precipitation is ~5 inches.
